
### House of Trump, House of Putin: The Untold Story of How Donald Trump and the Russian Oligarchs Made America Great Again

In 2013, Rybolovlev Free Downloadd a \$95 million apartment in Trump Tower in New York City. The sale was brokered by Ivanka Trump, Donald Trump's daughter.
