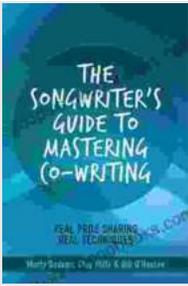

The Songwriter hereby sets, assigns, transfers and delivers to the Publisher, its successors and assigns, the original musical composition written and composed by Songwriter (the "Work") at present entitled **(NAME OF COMPOSITION)**, which title may be changed by the Publisher including the title, words and musical setting, and all rights therein, and all copyrights and the right to secure copyright and any extensions and renewals of copyright in the work and in any arrangements and adaptations thereof, throughout the world and any and all other rights that the Songwriter now has or to which Songwriter may be entitled or hereafter could or might become entitled with respect to the Work, if those persons had not been made, throughout the world, to have and to hold the same absolutely unto the Publisher or its successors and assigns.

The Songwriter hereby covenants, represents and warrants that the Work, which is an original work, and that neither the Work nor any part thereof infringes upon the title or the literary or musical property or the copyright in any other work, and that Songwriter is the sole writer and composer of the work under the name and of all the rights therein, and has not, and has not assigned, set over, transferred, licensed, mortgaged or otherwise disposed of any right, title or interest in or to the Work or any part thereof, or any of the rights therein conveyed, and that he has not made or entered into any contract or contracts with any other person, firm or corporation whatsoever, affecting the Work or any right, title or interest therein, or in the copyright therein, and that no person, firm or corporation other than the Songwriter has or has had claims on, has claimed any right, title or interest in or to the Work or any part thereof or any use thereof or any copyright therein, and that the Work has never been published, and that the Songwriter has full right, power and authority to enter into this Agreement.

3. In consideration of this Agreement, the Publisher agrees to pay the Songwriter as follows:

(a) an advance of \$_____, receipt of which is hereby acknowledged, or any other sum hereafter or hereinafter advanced to the Songwriter, which total sum shall be deductible from any payments hereinafter becoming due to the Songwriter under this Agreement;

(b) a royalty of \$_____ cents per copy on all regular piano copies sold and paid for in Canada / the United States;

(c) a royalty of \$_____ cents per copy on any form of reproduction thereof sold and paid for in Canada / the United States;

(d) a royalty of \$_____ for each use of the lyrics and music together, in any song book, album, radio or television program containing at least four musical compositions;

(e) 50% of net proceeds of royalty statements, if a composition is granted and paid for in (Canada / the United States), or in copyright rights sold in (the United States / Canada), through (territory)

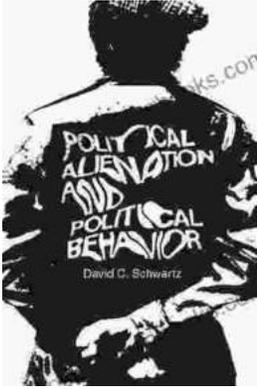
